Within the scope of the care duty regular investigations are carried out for critical raw materials to check the risk of genetically modified components.

Hence, we can confirm that with introduction Directive (EC) 1829/2003 no labelling duty exists for our product. In addition, our products do not fall under the scope of Directive (EC) 1830/2003 (EC) 1830/2003.

Packaging and utility items
